

Privacy Policy

This Privacy Policy sets out the data processing practices carried out through the use of the Internet and any other electronic communications networks by Financial Claim Solutions Limited.

Please note that all data thus captured will be used and held in accordance with the requirements of the Data Protection Act 1998 and the EU General Data Protection Regulation 2016.

Information collected

We collect information from visitors using online forms that can be found on various pages of our digital properties.

We collect your details when you contact us with an enquiry.

In addition to the above, we collect information automatically about your visit to our digital properties. Please see our Cookies Policy for more details.

Use of personal information

We process personal information collected for the purposes of:

- Dealing with your enquiries and requests
- Providing and personalising our services
- Providing information to you about products and services when appropriate, where you have given us permission, or we believe there is a legitimate interest to do so

We process anonymised data to better understand our current and future offerings and to enable us to improve our service.

General Data Protection Rights

When you supply personal information to Financial Claim Solutions Limited, we have a legal obligation to you in how we protect and use that information. We must, for example, tell you when we are collecting such data and why, and if we intend to pass this information on to a third party. You must give us your permission if you wish us to pass your details on to a third-party partner.

Permission to pass on referral data to a third party (in most cases this will be the legal partner) in order to progress the claim is implied by submitting an enquiry via one of our website forms.

We will not retain data longer than is necessary to fulfil the purposes for which it was collected or as required by applicable laws or regulations. When an account is finished, all personally identifiable data collected will be deleted or anonymised, as required by applicable law.

Subject access requests

You have the right to see what personal identifiable data we hold about you. Right to erasure (“right to be forgotten”)

You have the right for your personally identifiable data to be erased from our servers when requested for the following reasons:

- We are processing your personal data for marketing purposes only
- It is no longer necessary to keep your data for the services we have provided
- Your objections legitimately over-ride our reasons for keeping your data
- We have a legal obligation for doing so

We may not delete your personally identifiable data if:

- We have a legal obligation to continue to keep your data
- We have a legitimate interest in continuing to keep your data as part of our service to you

These reasons are not exhaustive. Should we believe your request is not valid, we will contact you with our reasons as to why. You then have the right to contact the Information Commissioner’s Office to report your concern.

There is no charge in having your personally identifiable data deleted from our servers and will be undertaken within 1 calendar month of the initial request we agree to do so.

Information Sharing and Disclosure

Financial Claim Solutions Limited will only send personally identifiable information about you to other organisations when we have your consent to provide the information or service you have requested, or if we are required to by law. Third parties include:

- Financial institutions with whom you have a complaint
- Financial partners providing named services
- Ombudsman Services as part of our service delivery to you
- Regulatory bodies under our legal requirement in law to provide such data
- Contracted document collection services

We keep your Personal Identifiable data securely via our own dedicated servers. We use a number of third party suppliers (known as “data processors”) to administer your account. Your personal data is not shared with these vendors.

- Customer Relationship Management systems to administer your account
- Email Service providers & other communication platforms to contact you regarding your account
- Printing organisations to print the personalised information pack
- Courier partners to send you information packs
- Social media platforms for the basis of digital marketing and advertising
